**TEAM MANAGER AND PLAYERS READ THE FOLLOWING STATEMENT BEFORE COMPLETING AND SIGNING**

In consideration of being permitted to participate in the NESAs, I hereby agree for myself, successor, heirs and assigns, release and forever discharge New Evolution Sports Association (NESAs), their employees, officers and directors from all claims, actions or judgments I may have or claim to have against NESAs for all personal injuries, including death, and injuries to property, real or personal, caused by or arising out of my participation in the NESAs; either Leagues or Tournaments. I further agree for myself, successor, heirs and assigns to indemnify and hold NESAs harmless from all claims and suits for personal injury, including death, damages to property caused by my act of omission arising out of participating in the NESAs and from all judgments recovered and from all expenses incurred in defending said claims or suits. I further agree that my photographs, pictures, slides and movies taken or made by NESAs, their employees, officers and directors, in connection with my participation in the NESAs either Leagues or Tournaments or any reproduction of the same, as well as my name, may in any manner be used by NESAs, or by a person, corporation or association authorized by NESAs. I am in good health and have no physical condition that would prevent me from participation in NESAs events.

NESAs Requirements: Roster must be signed by all players. The player is automatically ineligible if a signature appears on more than one roster, unless the player has a written release dated and signed the team manager of the team for which the player will not be a member. The release must be filed with the Regional Director before the team plays in a tournament leading to a State or National Championship. Team Rosters must be submitted to the State Director for teams qualifying for State and National Championships. By signing, I am aware of the penalties for using or possessing an altered bat. I am aware that the batter/owner will be suspended from all NESAs play as stated in the NESAs Rule Book. Failure to surrender any bat upon request will result in immediate suspension. The undersigned, have read and understand the foregoing release.
